TERMS AND CONDITIONS OF THE POOL RENTAL

Pool rentals will take place after the regular operating hours of the swimming pool during the designated times listed above. All City of Lenexa, Kansas ordinances and pool safety rules MUST be observed at all times. All personal and group property must be removed at the end of the rental. Alcoholic beverages and cereal malt beverages are not permitted at any time. Pool rentals will follow the Parks and Recreation inclement weather policy - weather line: 913-477-7170. This rental agreement is not transferable to any other person or group.

I agree to release, indemnify and hold harmless The City of Lenexa, Kansas, its officials, officers, employees, agents and volunteers from any claim arising out of the use of the facility/facilities, including but not limited to accidents, injuries, illness or loss of group or personal property relating to the use of the facility/facilities.

I further understand that as the individual requesting this permit and consenting to be the responsible person, I will be present at the function for which the facility is reserved and remain on site during the entirety of the function. I agree to assume the responsibility, including financial responsibility, for paying for any and all damage or loss that may occur to the facility/facilities and/or its equipment and supplies during our usage. I understand that if any violation of city, county, state or federal law, or a violation of the rules and regulations governing facility use occurs may result in the immediate termination of the function by the Lenexa Police Department and/or the Lenexa Parks & Recreation Department (LPRD) as well as loss of the ability to rent city facilities in the future.

I understand that this waiver includes claims either of a personal or property nature arising out of accidents, intentional or negligent torts, acts of God, attorney fees, loss of service claims, other expenses or claims based upon a subrogatable interest of an insurer. I grant this waiver on behalf of my children, heirs, successors and assigns.

The City of Lenexa shall utilize its best efforts to make the facility available on the date it is reserved. However, I understand and agree that if the City is unable to provide the facility/facilities requested on the date for which it has been reserved, I am entitled to reimbursement of any deposit paid therefore, and I shall release and hold harmless the City from any all claims arising from the City's failure to provide the facility, including but not limited to any claim for consequential damages.

I agree full payment is due at the time of booking. I understand cancellations must be made in writing through email (parksandrec@lenexa.com), faxed letter (913-477-7151) or mailed to Lenexa Parks & Recreation, 17201 W 87th St Pkwy, Lenexa, KS 66219. I agree that if I cancel less than two weeks prior to my reservation date, no refund will be given. Reservation dates may be changed with ample written notice and if date is available. Refunds will be given due to inclement weather.
