MONTHLY RECURRING MEMBERSHIP

- Debit/Credit accounts will be charged on the 20th day of the month or the next City of Lenexa business day.
- The monthly recurring payment option for memberships is a continuous membership which will remain in effect until a 30-day in-person notice of termination is given to the Lenexa Rec Center Welcome Desk. Membership will officially terminate following the expiration of the 30-day notice period on the 19th day of the month.
- I understand that in addition to my regular monthly payment, a \$30 non-payment reinstatement fee may be charged if there are insufficient funds in the bank account to cover the monthly payment, or if the automatic debit/credit card payment is otherwise declined. If a monthly payment is declined more than once during a 12-month period, privileges may be revoked and membership may be terminated. I understand that my

(and other individuals on the account, if applicable) access to and use of the Lenexa Recreation Center, including, but not limited to, day pass admission, may be suspended or otherwise revoked as a result of any outstanding balances. I understand and agree that in order to reinstate a membership or access to the facility, any and all outstanding balances must be paid in full.

- The City will provide 10 days prior written notice to a valid e-mail address on file before any recurring charge is submitted to my bank account or debit/credit account for payment.

ANNUAL MEMBERSHIP

The annual membership agreement is for a term of 12 months. Payment is due in full at the time of membership application. Renewals may be done online or in person at the Lenexa Rec Center Welcome Desk. No refunds will be issued.

TERMS OF MEMBERSHIP

By signing the membership application, I (we) agree to the following:

- Member and any guests in his/her party will abide by the terms of this agreement at all times during the period of the membership and will comply with all rules and regulations, as well as any lawful instructions and/or directions given by Lenexa Parks and Recreation staff or other City of Lenexa personnel.
- The City of Lenexa reserves the right to remove from the Lenexa Rec Center or terminate the membership of any member who fails to comply with any rules and regulations or otherwise breaches the terms of this agreement, in which case the member will not be entitled to a refund of fees. Removal of an individual from the Lenexa Rec Center will be in accordance with the procedures provided by the Lenexa Parks and Recreation User Conduct Policy, available online at www.lenexa.com or at the Lenexa Rec Center Welcome Desk.
- Memberships are non-transferable.
- In order to receive the Lenexa resident discount fee, proof of Lenexa residency for all persons over the age of 18 is required at the time of purchase. If an individual is not present at the time of purchase, proof of residency must be presented prior to the issuance of a membership key fob to said person. Proof of residency must be updated annually.

- Membership key fobs must be presented at the Lenexa Rec Center Welcome Desk to gain entry to the facility.
- Replacement membership key fobs are \$5 each.
- Anyone over the age of 18 not present during the purchase of the membership must sign the liability waiver before a membership key fob will be issued to said person. Liability waivers must be signed annually by all persons using the Lenexa Rec Center.
- From time to time, selected areas of the building may be closed for maintenance or repair throughout the year and members will not receive reimbursement for loss of access to such areas.
- Membership holders are responsible for notifying Lenexa Rec Center membership staff of any household address change.
- Lenexa Rec Center communications may come in the form of e-mails, phone calls and addressed letters. By signing below, you authorize Lenexa Parks and Recreation to send e-mail communications to your provided e-mail address.
- The Parks and Recreation Director reserves the right to amend and/or waive these terms and conditions as the Director deems necessary.

RELEASE OF LIABILITY

I hereby forever release and hold harmless the City of Lenexa, Kansas, its employees, agents and representatives from any and all claims of any kind that I, or my respective heirs, executors, administrators or assigns, may have or claim to have resulting from the use of the Facility or participation in said activities or programs. I recognize that there are inherent risks and dangers in the activities that I will take part in. I expressly agree to accept and assume all such risks existing in said activities, including risks of injury. I acknowledge that I have been urged and advised to seek the advice of a physician before I (or the participant) use the Facility or participate in any activity or program occurring at the Facility.
